I write in connection with your request for information, which was received by Nottinghamshire Police on 26/01/2015.

Following receipt of your request searches were conducted within Nottinghamshire Police to locate the information you require.

Please find below answers to your questions:-

#### **RESPONSE**

Under S 1 (1) (a) of the Freedom of Information Act 2000 (FOIA), I can confirm that Nottinghamshire Police does hold the information you have requested.

Do you have a dedicated Restorative Justice Team or contact?

Nottinghamshire Police do not have a Restorative Justice Team but the contact for the Force is PS 2187 Barton-Moran.

In the year 2013-2014, how many crimes were recorded by your force?

## In the year 2013-2014, how many offenders who had received Restorative Justice went on to reoffend?

This information is not recorded in an easily retrievable format. Nottinghamshire Police do not routinely record such information. To locate, retrieve and extract the requested information requires a manual search of all records held in relation to Restorative Justice for the requested period in order to ascertain if any recipients of RJ were repeat offenders. As above the search revealed a total of 3866 records over a 1 year period.

We estimate that it would take approximately two minutes per record to search should it be stated on the form however the names would then need to be extracted into a working sheet in order to identify any duplicates in relation to your question. At the most conservative we estimate this would take approximately 3 minutes per record in total which would equate to approximately 193 working hours (for 1 years' worth of records). This takes the request over the cost threshold of 18 working hours and engages Section 12 (1) of the Act.

This letter constitutes a refusal notice under Section 17(5) of the Freedom of Information Act 2000 with Section 12(1) of the act being applied

**12.** – (1) Section 1(1) does not oblige a public authority to comply with a request for information if the authority estimates that the cost of complying with the request would exceed the appropriate limit.

Should you wish for the Force to continue with your request, a more accurate figure will be provided within a fee's notice. The cost will need to be paid by you, prior to any further investigation. Please advise if you wish to proceed.

Alternatively you are invited to refine your request to bring it within the cost threshold, however due to the large numbers I am unable to suggest a refinement that would do so.

In accordance with the Act, once one part of the request is excess cost the whole request exceeds the cost threshold. However in the spirit of the Act, but outside of it, please find the responses to the questions which we were able to retrieve.

<u>Please Note</u>: Police forces in the United Kingdom are routinely required to provide crime statistics to government bodies and the recording criteria is set nationally. However, the systems used for recording these figures are not generic, nor are the procedures used locally in capturing the crime data. It should be noted that for these reasons, this force's response to your questions should not be used for comparison purposes with any other response you may receive.
