# Request under the Freedom of Information Act 2000 (FOIA)

I write in connection with your request for information, which was received by Nottinghamshire Police on 07/05/2014.

Following receipt of your request searches were conducted within Nottinghamshire Police to locate the information you require.

#### **RESPONSE**

Under S 1 (1) (a) of the Freedom of Information Act 2000 (FOIA), I can confirm that Nottinghamshire Police does hold the information you have requested.

Please find below answers to your questions:-

Is there a dedicated corporate communications / press department in this police force? If not, does your police force share or are in collaboration with another police force?

Yes, Nottinghamshire Police does operate its own communications department which is separate to that of the Office of the Police and Crime Commissioner.

What is the name of the department(s) that deals with public relations, the press and social media in this police force? And have there been any previous names that this department was known by?

The department is currently known as Corporate Communications. This department has previously been known as the 'Media Department' and the 'Public Relations' Department in the past.



## When was this department first established?

Approximately 20 years ago.

# Who has operational control of the department the Chief Constable or PCC? And is this likely to change in the next year?

The Chief Constable has current control of the department. There are no planned changes.

# How many people currently work in this department?

16 FTE posts

# How many people worked in this department in 2004 and 1994?

Information not held for 1994. In 2004 the establishment was 8 FTE posts.

# What is the yearly budget for this department from 2000-2014?

Nottinghamshire Police are only able to supply information for the period 2010-2014. Previous to this, budgets for this department were included within the total for the Corporate Development Department as a whole. Information relating to the Corporate Communications department were not held separately.

# Which social media / networking websites does your police force use? How many official Twitter accounts and Facebook pages are there for this police force?

Nottinghamshire Police has Force accounts with Facebook, Twitter and Youtube. In addition there are more than 40 Twitter accounts for Nottinghamshire Police Neighbourhood Policing teams.

How many complaints have been made between 2005 and 2014 regarding police officers or staff posting inappropriate comments/material online?

Nottinghamshire Police have previously answered a Freedom of Information request in relation to this matter which is available to view on the Freedom of Information Disclosure log on our website at the following link:

This information is therefore exempt from disclosure under Section 21 of the Act: Information reasonably accessible by other means.

This letter constitutes a refusal notice under Section 17 (1) of the Freedom of Information Act 2000 with Section 21(1) of the act being applied.

- **21.** (1) Information which is reasonably accessible to the applicant otherwise than under section 1 is exempt information.
- (2) For the purposes of subsection (1)
  - a) information may be reasonably accessible to the applicant even though it is accessible only on payment, and
  - b) information is to be taken to be reasonably accessible to the applicant if it is information which the public authority or any other person is obliged by or under any enactment to communicate (otherwise than by making the information available for inspection) to members of the public on request, whether free of charge or on payment.
- (3) For the purposes of subsection (1), information which is held by a public authority and does not fall within subsection (2) b) is not to be regarded as reasonably accessible to the applicant merely because the information is available from the public authority itself on request, unless the information is made available in accordance with the authority's publication scheme and any payment required is specified in, or determined in accordance with, the scheme.

Additionally, searches have been conducted for complaints recorded within the time parameters of your request but outside of the response provided above. One such complaint was found to be recorded.

How many investigations have been conducted / complaints received in relation to the inappropriate disclosure of information to third parties (e.g. press)both through conventional mediums and social media between 2004 and 2014?

This information is not recorded in an easily retrievable format. To locate, retrieve and extract the requested information requires a manual search of all records held to establish whether the recorded complaints fell within the scope of your request. An initial search revealed a total of 169 records over the period requested.

It is estimated that to search one record would take approximately 10 minutes which would equate to approximately 28.17 working hours. This takes the request over the cost threshold of 18 working hours and engages Section 12 (1) of the Act.

**12.** – (1) Section 1(1) does not oblige a public authority to comply with a request for information if the authority estimates that the cost of complying with the request would exceed the appropriate limit.

Should you wish for the Force to continue with your request, a more accurate figure will be provided within a fee's notice. The cost will need to be paid by you, prior to any further investigation. Please advise if you wish to proceed.

Alternatively you are invited to refine your request to bring it within the cost threshold – perhaps by reducing the number of years you require data for, and resubmitting the request.

In accordance with the Act, once one part of the request is excess cost the whole request exceeds the cost threshold. In the spirit of the Act but outside of it I am happy to provide you with that information as above which was able to be retrieved within the cost threshold.

#### **Complaints Rights**

Your attention is drawn to the enclosed review procedure, which details your right of complaint.

#### Copyright

Nottinghamshire Police in complying with their statutory duty under Sections 1 and 11 of the Freedom of Information Act 2000 (FOIA) to release the enclosed information will not breach the Copyright, Designs and Patents Act 1988. ## Are you dissatisfied with your response?

The review will be undertaken by someone different from, and preferably senior to, the original decision maker and this should be completed within 20 working days from receipt, in exceptional circumstances it may be extended by a further 20 working days.
