Following receipt of your request searches were conducted within Nottinghamshire Police to locate the information you require.

RESPONSE

Under S 1 (1) (a) of the Freedom of Information Act 2000 (FOIA), I can confirm that Nottinghamshire Police does hold the information you have requested.

Please find below answers to your questions:-

- 1. How many officers have been offered provided with counselling services in the financial years of:
- (a) 2012/13
- (b) 2013/14
- (c) 2014/15*

Please note the following:

- Employee Assistance Provider (EAP) information is provided by calendar year, rather than financial year.
- PMI (Funding for private Intervention) figures relate to financial years.
- EAP figures are not split into officers and staff they do not separate this information
- PMI data relates to officers only.



- (a) **2012/13** 16 Officers received counselling via the PMI scheme (funding for private intervention).
- (b) In 2013 113 individuals (Officers and Staff) received counselling via the Employee Assistance Provider (EAP)
- (c) 2013/14 11 Officers received counselling via the PMI scheme
- (d) **2014** 100 individuals (Officers and Staff) received counselling via the EAP
- (c) **15* 14/15** 8 Officers received counselling via the PMI scheme **2015** 6 months to date, 61 individuals (Officers and Staff) received counselling via the EAP

Occupational Health Services are regionalised across the East Midlands Police Forces. Each Force will contribute to the cost of providing EAP services however, this will not be broken down into those costs directly associated with providing counselling services only. We are able to provide the below information regarding the amount of funding approved for PMI (private intervention) only:

- (a) 2012/13 PMI funding approved £10,070 + proportion of regional EAP costs
- (b) 2013/14 PMI funding approved £7,280 + proportion of regional EAP costs
- (c) 2014/15* PMI funding approved £8,760 + proportion of regional EAP costs * To date of request

Data provided by the EAP includes both Police Officers and Support staff and is not held separately. Data is reported in calendar years.
