Request under the Freedom of Information Act 2000 (FOIA)

I write in connection with your request for information, which was received by Nottinghamshire Police on 26 April 2013.

Following receipt of your request searches were conducted within Nottinghamshire Police to locate the information you require.

Please find below answers to your questions:-

RESPONSE

Under S 1 (1) (a) of the Freedom of Information Act 2000 (FOIA), I can confirm that Nottinghamshire Police does hold the information you have requested.

Please could you provide figures for the number of reported thefts of fuel, both petrol and diesel, direct from private vehicles in your force area for 2012, 2011 and 2010. Not including theft from garage/dealer forecourts.

We would like the information to include the details of the theft in terms of how the fuel was taken from the vehicle, in either of the following ways:

Drilling the tank and draining the contents
Siphoning
Other

Please Note-: The data above includes Moped, Motor Bikes, Private Cars and Transits but does not include vehicles attached in Compounds, Sites and Hire Vehicle

Please Note-: This data has been extracted from a live crime system and may be subject to change

We would also like to know the conviction rate for vehicle fuel theft from private vehicles for the same period in your force area.

This information is not recorded in an easily retrievable format. To locate, retrieve and extract the requested information requires a manual search of all records held in relation to these offences to determine whether a charge was brought and against whom. It would then necessitate this information being cross referenced against the Police National Computer (PNC) to establish whether a conviction was received by the offender(s). This would require all 460 of the identified offences above being manually searched.

A sample search took around 5/10 minutes for one record which would equate to approximately 38.33 working hours (at the more conservative estimate of 5 minutes per record). This takes the request over the cost threshold of 18 working hours and engages Section 12 (1) of the Act.

This letter constitutes a refusal notice under Section 17(5) of the Freedom of Information Act 2000 with Section 12(1) of the act being applied

12. – (1) Section 1(1) does not oblige a public authority to comply with a request for information if the authority estimates that the cost of complying with the request would exceed the appropriate limit.

Should you wish for the Force to continue with your request, a more accurate figure will be provided within a fee's notice. The cost will need to be paid by you, prior to any further investigation. Please advise if you wish to proceed.

This information would be better obtained directly from the Courts.

Formal Independent Review

Upon receipt for a review of the initial request response, an independent audit officer from Information Management will review the request and assess whether it has been satisfactorily processed in accordance with policy and procedure.

The Audit officer will record and communicate his/her decision to the information requester within 20 working days.

Appeals

If the findings of the formal independent review do not meet your approval, you can register an appeal against the decision.

An investigation will then take place by the Freedom of Information officer, which will be reported and presented to the Internal Appeal Board. This will include a full account of the reasoning for or against disclosure and the application of any relevant exemptions.

The Internal Appeal Board will consist of at least a member of the Chief Officer Team, a member of the Legal Team and the Force Information Manager.
